Why the AchtAnois online activism became a talking point within Irish society?

2016 was a year when this online activism spread like a wildfire in a cornmaze. Immediateky after the appointment of a new Minister of Education in Northern Ireland (Peter Weir), all Irish text was removed from the Department's website; this set a clear precedent for the treatment of Irish and the Irish language community that year.

That year, a myriad of people decided to join the AchtAnois movement on social media. This occurred after the passing of unlawful legislation to remove vital funding for the establishment of nurture units in Scoil an Droichid in Oirthear Bhéal Feirste (East Belfast). Also in Bunscoil Bheann Mhadagáin in Tuaisceart Bhéal Feirste (North Belfast). This was seen only as the beginning.

However, this particular online activism had not become too popular on social media for another four years. (Twenty-four years after the initial agreement to implement Irish language legislation and recognise An Ghaeilge as an official State language).

On May 12<sup>th</sup> 2022, Deputy First Minister of Northern Ireland at the time, Michelle O'Neill, tweeted; "Thousands parading for irish language rights today in Belfast. It's time for AchtGaeilge to be delivered. AchtAnois DeargLeFearg". This caused a plethora of an effect for the activism. Causing; 199 comments, 1070 retweets, and 6777 likes.

Everything changed after the online activism AchtAnois. A lot of pressure was put on politicians to make Irish an official state language. The (Deputy) First Minister ag the time Michelle O'Neill announced that the "UK Government has a duty to prepare and implement this".
